## PRESIDENT'S MESSAGE

### SERVING ON THE BOARD OF DIRECTORS A POSITIVE EXPERIENCE

Four years ago I knew nothing about the way in which the Association of Northwest Weavers operated as an organization even though I had attended, and greatly enjoyed, ANWG conferences in Eugene, Tacoma and Spokane. I was surprised when I was asked if I would serve as either President or First Vice-President on the ANWG Board. Having been the president of our local guild and a couple of other organizations, I was comfortable with what a President usually needs to do....but to go into an organization about which I knew very little was a little intimidating.

I agreed to serve as First V-P only if Linda Davis (whom I knew as a president and ANWG Rep of our guild) would agree to be President. Linda has been involved with ANWG for many years and knew many of the people involved. Four years later, I am glad that I said "Yes".

The stated duties of the First Vice-President are to support the President and step in as President, if needed. Wanting to learn more about the organization, I volunteered to work on the logistics of the Annual Meeting in 2010. ## **YOUR HELP IS NEEDED!! SERVING ON THE ANWG BOARD**

The Association of Northwest Weavers Guild is no different than our individual guilds, where we need to step in and use our talents and abilities to make the organizational part of our guilds function well. Having people from guilds in our member states and provinces serve in the various positions on the Board of Directors (elected every two years at our conferences) is what allows us to continue living up to our founding purpose:

1. To stimulate and encourage public interest in handweaving throughout the northwest region of North America,
2. To support conferences and educational endeavors in handweaving throughout this northwest region,
3. To aid and encourage current and prospective handweavers in the general art and craft of handweaving as a technical and artistic endeavor. (from our Bylaws)

At our Bellingham conference we will again be electing a new Board of Directors. Fortunately, most of the current Board members are willing to serve for another 2 years. As President for the past two years, I move to the position of 2<sup>nd</sup> Vice President where I will look for the next Nominating Chair and do whatever I can to support the new President. In some years the First Vice-President has moved into the position of President, but Joy Winther, when she agreed to serve as First V-P two years ago, indicated then that she would only be able to serve for 2 years and would not be able to move into the position of President.

With the majority of the Board willing to continue serving in their current positions for another two years, we now need to find two people: a President and a First Vice-President to complete the slate for our election in June.

## **WANTED: ANWG WEBMASTER**

On or before September 1, 2013 we need to find a webmaster. Linda Davis will be retiring from the board and this job after almost 10 years. Please help us find someone by passing on this information to anyone you know who may be interested and willing to take over this duty.

The website utilizes the WordPress platform and is easy to learn and maintain. Maintenance can be done by more than one person; at this time three people help in maintaining the site. At most times, only a few minutes per day, or a few minutes per week, are required. Technical assistance from the webhost is available if problems arise that cannot be addressed by the webmaster. No software purchase is required by those maintaining the site and maintenance can be done from any computer anywhere in the world and even from most mobile devices.

If you know someone who would be interested and willing to take over the webmaster duties, please let Linda Davis or an ANWG board member know. Please announce this position to your guild members. This position is a good way for someone to learn about development and maintenance of websites generally. If someone is interested but has no experience or training, if they have the basic understanding of computer functions and the internet, they can learn quickly. It's fun, interesting, and a great way to keep in tune with what's going on in the fiber arts world!

To help in future conference planning, the Seattle Guild will be passing along several things they have found successful in planning the current conference. **REGISTRATION INFORMATION FOR THE ANNUAL MEMBERSHIP MEETING**  
**June 23, 2013 8AM - 10AM**

As a result of the changes to the bylaws that were approved at last year's Annual membership Meeting, the registration for the Annual Meeting has been simplified. For the annual meetings that occur during the conference, you do not have to register in advance: please register with the Secretary when you arrive for the meeting. Registration opens at 7:30 AM. There is also no longer a requirement to attend the Annual Meeting in order to remain a Guild in good standing with ANWG. If no one from your Guild is able to attend you may designate a representative or alternate (a proxy) from another Guild to attend the meeting on your behalf, but you do not have to. If you wish to do this, please contact the Secretary by email: [jmgriffiths@shaw.ca](mailto:jmgriffiths@shaw.ca) for the proxy form. Request a proxy form only if appointing a proxy from another ANWG member guild. You do not need a proxy if another member of your Guild is attending instead of the Guild's ANWG Rep.
