The membership of ANWG remains constant as to the number of guilds but the number of members has decreased slightly since 2016, the reduction is in the Canadian guild members. Current membership is 86 guilds and 4084 members. There are two affiliate guilds, MAWS and WeGO. We have lost four guilds in the last four years. We need to find ways to keep older members interested.

The newsletter has been published quarterly and contained the President's message, news from ANWG, news from guilds, and upcoming fiber arts events Ila thanked all who have contributed to the newsletter. Bylaws

The proposed bylaws update to change the fiscal year to correspond with the IRS tax year was voted on and approved. Article VII, #3 of the ANWG bylaws was amended to read:

The Executive Board shall prepare and adopt a budget at the beginning of the fiscal year and ensure that the financial records of ANWG are reviewed at the end of each Treasurer's term, or every two years if the Treasurer holds two consecutive two-year terms of office. The fiscal year shall be from July 1 to

June 30 to correspond with the IRS tax year and required filing of the non-profit corporation 990-N e-postcard return.

This information will be posted on the website.

Written questions to the board

One question was received regarding ease of non-computer users to register for conference. It was suggested that each guild help its non-computer using members to register. Also, classes fill and teachers have set the limits on the classes. Please be open to taking a different class and learning something new.

2021 Conference Report

2019 Annual Membership Meeting

Membership Summary as of May 2019

4084 Individual Members within the guilds

86 Guilds - down from 87 in 2018

Two of our guilds are affiliate Guilds with large membership

Montana Association of Weavers and Spinners

Weavers Guilds of Oregon

1 Guild chose not to renew this year, and we've lost 4 guilds over the past 4 years

Total membership count from renewed guilds, US = 2615

Total membership count from renewed guilds, CA = 1469

Total guilds renewed, US = 50

Total guilds renewed, CA = 36

We have 4 affiliate members this year.

In comparison, over a four-year period, 2016-2019:

There has been a net decrease in overall membership within guilds between 2018 and 2019. We've had a slight net increase in US guilds (10 members) and a larger decrease of 84 members from the Canada Guilds. The one guild in Canada which chose not to join this year registered 10 members in 2018, so that didn't account for the lower numbers for the Canadian Guilds. Our non-returning Canadian Guild registered as a new guild in 2018, so perhaps they didn't have enough interest to sustain the year. We'll keep them on our records and will hope to welcome them back in the fall. It may be that our Canadian members in attendance have seen reduced membership in their own guilds and we'd be curious to know their ideas.

On a very high note, since being the membership chair as of June 2016, I was almost overwhelmed with the dues responses starting even before September of last year. I hardly used my harassment tactics on our guilds through the winter and was delighted to have 94% accounted for by the end of 2018. We always have a few slow pokes, but that gives the opportunity to request dues and wish good holiday tidings to soften the blow.

ANWG Challenge Grant Proposed Guidelines

April, 2019

The Challenge grant program that ANWG has funded the past 5 years has been a huge success. It was started in 2014 to provide funding for individual guilds to provide an educational opportunity for their members in lieu of a regional conference in 2015. The response has been so great, all the profits from the treasury prior to 2015 and the profit from the 2017 Victoria conference have been disbursed to guilds in three grant rounds.

In 2015, 29 guilds received a total of \$17,400

In 2016, 24 guilds received a total of \$14,400

In 2017-18, 25 guilds were awarded a total of \$15,000; two events are cancelled so the actual grant expense disbursed is \$13,800. There were 37 applications.

Half of our 85 guilds have applied for a grant at some time.

2 guilds have received three grants

13 guilds have received a grant twice

10 guilds have received a grant once

The grant selection committee in 2017-2018 established an extensive points system to evaluate each application on the same merits and be fair about the selection process. If a reviewer recognized the event, they did not score that application. All applications were scored without the guild or location names.

The Board feels it is time to evaluate this award process and set some guidelines for future ANWG boards to use or modify as they see fit. We want to encourage the guilds that haven't applied before to generate an event/workshop and apply for any future conference profits awarded as grants.

Several previous ANWG boards and this current board have voted to only use future conference profits as grant awards. The ANWG treasury has been depleted down to the bare minimum needed to support the conferences with seed monies and to carry on the annual meetings and duties of the organization. The only revenue source for future grant awards is the 20% ANWG portion of the total conference profits after all expenses are paid. In the event that there is no profit to distribute, no grants will be offered. In the event that the conference is unprofitable and the seed monies paid out to fund part of the initial conference expenses are not paid back, no grants will be awarded until the deficit is recovered from another source, either an increase in ANWG dues or future conference profits.

Suggestions for grant guidelines from the current Board are:

1. Allocate only ANWG's portion of the biennial conference profit for grant awards, keeping a sustainable balance in the accounts for ANWG funding as has been approved in the past.
2. Giving all or part of the grant money to individuals to attend outside workshops or conferences is not allowed, guild scholarships are for that purpose.
3. Grant funds are to be used to benefit as many members in the guild/area as possible and/or educate the public in the various fiber arts.
4. Develop an online grant application form on the website before the next grant round.
