ANWG MEMBERSHIP REPORT Liz Moncrief, Membership Chair Annual ANWG Board Meeting Online, May 21, 2020

Membership Summary as of May 2020

There has been a net increase in overall membership within guilds between 2019 and 2020 of 92 members despite losing a guild this past year. We hope that the lower number might account for this being an 'even' year when we have a membership meeting rather than a conference. We do, however, have more individual/affiliate members this year which is always encouraging. We'll keep those non-renewing guilds on our books thru this year to keep them updated on ANWG's activity and are hopeful that they'll decide to come back to us.

Something exciting that we're working on this year is to facilitate electronic payments for guild and affiliate dues. We realize that not all guilds have their own credit cards; however some may consider using an individual's personal card to pay for the dues, and then be reimbursed by their respective guild. This would relieve our Canadian Guilds of having to pay for a bank draft in US dollars. The electronic transaction will account for the currency exchange. Guild Reps will still be required to submit an annual membership application with their current guild information. This can be filled in through the ANWG website or with a hard copy to be mailed as usual.

I appreciate those guilds that have made an extra effort to get their dues paid in a timely manner and an extra shout-out goes to **Methow Valley Spinners and Weavers Guild** for being first in line this year. Chocolate will be on the way. Please keep me posted on Representative changes during the year and let me know what I can do for you and your guild to make the process easier.

Annual ANWG Board Meeting Online, May 21, 2020

Webmaster and Education Chair Reports, Isabelle Fusey

Webmaster

Following a severe hack in June 2019, our website northwestweavers.org is now very stable. The classifieds section continues to be very active. Many thanks to Mary Wonser from Bend Oregon who is stepping down after posting ads for seven years. Domain registration and hosting was transferred from Canvas Host to HostGator in January 2020. We are currently seeking a new webmaster (Isabelle Fusey will remain as backup webmaster as long as required).

Education Chair

A small but enthusiastic group of weavers is continuing to explore the weaving history of the Pacific Northwest. The current "For the Table" challenge includes submissions inspired by Mary Meigs Atwater, William Bateman, Oscar Beriau, Robin and Russ, and Joan Patterson who was a pioneer of the linen industry in Oregon.

Noh Coat

The Noh Coat challenge is continuing to gain traction with inquiries trickling in every week. The challenge is to make a coat from handwoven fabric using a pattern based on the work of American fashion designer Bonnie Cashin. Toby Smith and Isabelle Fusey have shared the pattern, generously provided by Threads Magazine, with approximately 150 people so far and the online discussion group counts about 100 members. How many of us will be parading in Noh coats in Salem in June 2021 at the ANWG Conference is still unknown.

ANWG 2023 Conference Report

Theme has been chosen: Montana Fiber Magic

A logo has been designed.

Conference colors have been chosen.

Dates are to be determined. Early June seems to be the time that has the most appeal.

Venue: Montana State University Billings is unavailable for conference because the university is unable to commit to an event more than 12 months in advance. The committee toured several hotels and the MetraPark event center through arrangements made by Visit Billings. The best fit for the conference seems to be the Doubletree in downtown Billings. Visit Billings will support and promote the conference if we book one of the hotels we toured.

There are 3 positions on the committee that remain unfilled.

Due to the Stay Home orders in the state of Montana the committee has not met for the past 2 months. Currently we are in a waiting mode as the state of Montana begins to reopen.

I am closely watching the state, regional and national response to the pandemic and I am hopeful we will be able to begin working on the conference again soon. Given the projections about the course of this illness, the possible duration of 2 years or more of the pandemic, and the state of the US economy, I anticipate a much smaller conference from what we had started to plan for.
